

Bonefish Grill Give, Get and Win Sweepstakes

**OPEN TO RESIDENTS OF THE UNITED STATES, 18 YEARS OF AGE AND OLDER ONLY,
RESIDING IN THE FOLLOWING: AR, AL, CO, FL, GA, IA, ID, IL, IN, KS, KY, LA, MD, MI, MO, MS, NC,

1. HOW TO ENTER: Two ways to enter: (1) Beginning on November 1, 2009 through December 31, 2009 (“Promotion Period”) purchase and register a Bonefish Grill gift card at bonefishgrill.com and be automatically entered into the Sweepstakes. Gift cards purchased at a restaurant or authorized third party must be registered online at bonefishgrill.com in order to be eligible. (2) To enter without purchasing or registering a gift card, handprint your full name, complete mailing address, daytime telephone number on a piece of paper and enclose in a stamped envelope to: PO Box 409 Watertown MA 02471-0409. Mail-in entries must be postmarked by 12/31/09 and received by 1/7/10. Limit of one entry per email address, person or household throughout the Promotion Period, regardless of the method of entry. 2. ELIGIBILITY: Open to residents of the United States 18 years of age and older as of November 1, 2009 residing in AR, AL, CO, FL, GA, IA, ID, IL, IN, KS, KY, LA, MD, MI, MO, MS, NC, NE, NV, NJ, NY, OH, OK, PA, SC, TN, VA, WA, WI or D.C, except for employees of Bonefish Grill, LLC (“Sponsor”), Allen & Gerritsen (“Judges”), their affiliates, parent companies, subsidiaries and agencies (collectively “Promotion Parties”), and members of their immediate family or persons living in the same household.
